Selection Criteria

The following criteria will be used by the National Council to select participants:

- Originality: Selected participants will highlight new technologies that represent the future of health care.
- **Relevance:** Selected participants will show how their innovation is applicable to mental health and addiction treatment providers and the communities they serve.
- Outcomes: Selected participants must demonstrate the potential for improved outcomes.
- **Ability to Inspire Action:** Participants should inspire attendees to return to their organizations and apply what they learn to their own innovations.

All proposals must be complete, comprehensive, and deemed relevant and timely to the conference's audience. All presenters will be contacted independently to confirm their participation. Those selected to participate in the Shark Tank event originally planned for NatCon20 are encouraged to re-apply and will be given special consideration.

Notifications

Once you have submitted your proposal, you can expect:

1. Acknowledgement: Upon receipt of your submission, you will receive an email acknowledgement.

- 2. **Notification**: You will be notified about the status of your presentation by March 1, 2021.
- 3. Acceptance and Next Steps: If selected, you will be asked to record a video with National Council for Behavioral Health and innovaTel Telepsychiatry representatives in March 2021. All selected participant videos will be posted on the NatCon21 website and voted on by the public. The leading vote getters will give a 5-miunte pitch in front of the Shark Tank judges and a live audience made up of behavioral health leaders, clinicians, industry experts and entrepreneurs during NatCon21. Judges will have an opportunity to ask questions and audience members and the judges will vote on the winner. One winner will be awarded the \$10,000 grand prize.

All accepted presenters will receive access the Speaker Resource Center (SRC). Presenters will be required log into the SRC to confirm participation in the Shark Tank competition and provide a few additional items by the given due date(s).
